

# KINGSTON BOARD OF HEALTH MEETING MINUTES March 23, 2009

## **Health Agent's Report Reviewed**

Issue with John J. Geary, Dan Sapir to recuse himself from discussion he has utilized Attorney Geary in the past.

The Health Agent has another letter attached to her report pertaining to Attorney Geary stating that he would not be able to attend tonight's meeting. And would like to be put on the agenda in May. Attorney Geary tied into the Municipal Sewer last year and has not abandoned his septic system. The regulations require that a septic system be abandoned once it is tied into the Municipal Sewer. The Board would like to ask Attorney Geary to come to the next Board Meeting on April 13<sup>th</sup>. Have Health Agent place a cordial call to Attorney Geary and invite him to our next meeting on April 13<sup>th</sup>.

Smoke-Free State Law Compliance checks were conducted on March 9, 2009. Six establishments were chosen and there were zero violations.

The attached letter was received from the Kingston Recycling Committee. On Thursday, March 5, 2009, the Kingston Recycling Committee voted unanimously to request that the Kingston Board of Health take into consideration adopting rules and regulations requiring all private Haulers doing business in the Town of Kingston to adopt the best practices regarding recycling and waste collection. The Board would like to hear from one or two haulers about recycling. Have the Health Agent contact Plymouth and ask how did this occur? Now they have been doing this for a couple of months, is there any data they have gleaned from a short period of time? And the Board would like to have minutes from the last 2 or 3 meetings of the Recycling Committee.
